#### Item #1 Chairperson's Remarks

Professor R. Peterson called the meeting to order. The UBC was thanked for supplying the coffee and donuts.

#### Item #2 Dean's Remarks

Dean Horvath announced that Prof. Lorna Wright will be the new IMBA Director beginning September 1, 2000. Prof. S. Weiss, the current IMBA Director, will be stepping down at the end of June. Hiring/recruiting is continuing with interviews scheduled for the Financial Services chair and in the Marketing department.

The University has appointed the company of Taylor Hariri Pontarini as the architects for the new Schulich Building. The retreat held June 1, 2000 was a useful venue and concerns regarding the new building that arose at the retreat will be addressed, if they have not already been dealt with.

The International Executive MBA Program will be an attractive project for the Schulich School of Business. On June 12, 2000, Dean Jacobs from the Kellogg School of Management, Northwestern University visited Toronto and met with the Dean and also Professors T. Beechy, and P. Bradshaw who are currently on the EMBA Taskforce. Prof. G. McKechnie will begin the process to elect a faculty member to this taskforce.

Convocation is scheduled for Friday, June 16, 2000, and the Dean reminded the Faculty to participate in this event.

Professor Peterson thanked Dean Horvath for his comments at all the Faculty Council meetings throughout the 1999-2000 season. Professor Peterson also acknowledged and congratulated both the Dean and Prof. J. McKellar for all their hard work and efforts in making the new building a reality.

Dean Horvath thanked Professor E. Fischer for her hard work and positive contributions as Director of the MBA Program over the past year. Professor P. Bradshaw will be the MBA Director for 2000-2001. Also Dean Horvath acknowledged and thanked Professor S. Weiss for all his contributions during his five years as the IMBA Director and as mentioned early, Professor L. Wright will be the new IMBA Director for Fall 2000.

# Item #8 Tenure and Promotions (Committee of the Whole)

Professor W. Cook reviewed the Agenda information which has been revised to include the suggestions from the Committee of Whole discussion that took place on May 26, 2000. The T & P Committee are attempting to make this a more consistent and formal process that is more in line with the rest of the University. Discussion took place on the exact wording that would be the most suitable. Because of the length of the discussion, Dean Horvath suggested that the remainder four motions be forwarded to the first meeting in September/October 2000. The first two Motions were rephrased as follows

Professor C. Oliver moved Motion #1 - The Faculty Tenure & Promotions Committee will work with each new faculty member and his/her hiring committee to select an existing member or body of the Faculty, who will serve as the candidate's mentor to provide advice and feedback right from the beginning of the appointment through to the file preparation. Seconded by Professor G. McKechnie. Motion Carried.

Professor C. Oliver moved Motion #2 - File preparation will be the responsibility of the candidate, under advisement from the Faculty Tenure & Promotions Committee, the area or equivalent body, and the candidate's mentor. Seconded by Professor G. McKechnie. Motion Carried

# Item #10 Nominating Committee

Prof. G. McKechnie moved that Faculty Council approve the revised Nominating Committee slate for the 2000-2001 year. Seconded by Charmaine Courtis. Prof. McKechnie noted that the T & P Committee turned over completely and Professor W. Cook will stay on as advisory. Motion Carried.

#### Item #11 Other Business

Prof. D. Dimick moved the acceptance of SSB Faculty Council Rules of Membership, seconded by Prof. D. Johnston. Prof. Dimick explained that Senate Executive has requested rules of Faculty Council be submitted from each Faculty. Prof. Fischer enquired about emeritus status and Prof. Dimick stated that they were not included on the Faculty Council Voting membership. Motion Carried.

The SSB Committee Reports were accepted.

The SSB 2000-2001 Faculty Council dates were accepted.

Prof. G. McKechnie moved the Delegation of Faculty Council Powers, seconded by Charmaine Courtis. Motion Carried.
